Ordinance No. 017744 was adopted by the City of El Paso on March 6, 2012.

- □Purpose: Establishes criteria and process for officially recognizing neighborhood & civic associations in El Paso.
- □ Criteria for recognition: Applicants must meet minimum standards (e.g. 15 members for neighborhood associations, 100 members for civic associations, must have defined boundaries, officers, and meet at least once yearly) to be recognized

- Benefits of City recognized associations:
  - Neighborhood Services as a liaison to connect with other city departments
  - Quarterly newsletter, technical and administrative support
  - Notices on planning applications, zoning, special permits, etc.
  - Invitations to citywide programs & opportunities (e.g. for quality-of-life improvements)
- ☐ Suspension/Revocation: Status can be suspended or revoked if rules aren't followed.
- ☐ **Boundary Disputes:** Settled by permit official, with right to appeal.
